ANNOUNCEMENT National Institute of Development Administration New Application for Admission Master of Economics Program in Economics and Management (English Program) Batch 9 Semester 1 Academic Year 2024

The National Institute of Development Administration (NIDA) is accepting applications for admission to the Master of Economics Program in Economics and Management (English Program) Batch 9 for the Semester 1 Academic year 2024 as follows :

1. Qualification of the Applicants

Applicants must hold a bachelor's degree in any field or major from an accredited academic institution. or Applicants who are studying in their last semester must graduate with a bachelor's degree on or before the first day of the semester for which they have been accepted

Note : Student must submit TOEFL score at least 500 PBT, 173 CBT and 61 iBT or IELTS SCORE at least 6.5 or NIDA TEAP score at least 500 within Semester 1 Academic Year 2024.

2. Selection Procedure

The committee will interview and consider by the faculty members of the Graduated School of Development Economics. The committee will evaluate applicants based on credentials, education, and experiences.

3. Online Application

3.1 Application fee 200 baht

3.2 Applicants can visit http://entrance.nida.ac.th and have to follow the following instructions :

1) Register for getting into the online application system.

2) Set a password and confirm

3) Apply for entrance examination by choosing a school and a program of study.

4) Fill out profile information.

5) Confirm the application.

6) Print an invoice of application fee.

7) Save the application information, verify the information and confirm the application.

8) Print a bill payment fee 200 baht for the application and the payment must be made by May 16th 2023
