on Schedule for Comprehensive Examination
Regular Students in the Master of Economics in Economics and Management Program
1st Round for Academic Year 2024

By the virtue of Section 71 Part 11 of Directives of National Institute of Development Administration on Education B.E. 2563 (2020), the Graduate School of Development Economics hereby announces the following details on comprehensive examination for regular students in the Master of Economics in Economics and Management Program of the 1st round for academic year 2024.

1. Qualifications of Students who are eligible to sit for the comprehensive examination

- 1.1 Students must complete the coursework of the program with not less than 3.00 grade point average.
- 1.2 The grade point average of core courses as shown below must not be lower than 3.00.
 - EX 6010 Managerial Economics
 - EX 6020 Analysis of Open Economy
 - EX 6030 Economic Policy
- 1.3 Students must submit the school the NIDA TEAP or TOEFL or IELTS result.
- 1.4 Students must pass Computer literacy test.

2. Application and Payment Schedule

August 5th – 9th, 2024

3. Application Procedure

- 3.1 Students can apply online on the Education Service System website in the address <http://reg.nida.ac.th>
- 3.2 Students login to the system and click **Comprehensive Examination** menu for confirming the exam application. Then, students can print a bill payment.
- 3.3 Students can pay their bill payment at Bangkok Bank, Internet Banking and Counter service all branches.

Fees are as follow:

- Comprehensive Examination fee 500 baht/exam
- Student status maintenance fee 2,000 baht/semester
- Payment fee according to charge of each channel

In the event that students lack required qualification, they will not eligible to take the exam and receive a refund of Comprehensive Examination fee.

6. Independent Study Presentation

6.1 Students who study plan B and apply for the comprehensive examination are required to present their Independent Study **Between** Saturday 31st August – Sunday 1st September 2024 at the National Institute of Development Administration.

6.2 Students must submit one-page Independent Study Infographic in landscape orientation with Abstract in PDF format **by August 21st, 2024** via the following link.

6.2.1 Infographic size limit is 10 MB. (Name a file: **Students ID_info**)

There must be a Name-Surname, Student ID, and the school Logo in the infographic without advisor's name.

6.2.2 Abstract (Name a file: **Students ID_abstract**)

6.3 Students must be able to present their independent study in infographic format for examination committees to understand.

6.4 Presentation time will be 5 minutes per person.

6.5 Asking questions of examination committees depend on the clarity of the students' Independent Study Presentation. In this regard, the committees may ask students more questions of knowledge and understanding of curriculum content.

6.6 If students are unable to submit their infographic and abstract by the due date, they will not be eligible to present their Independent Study. It will be considered that the comprehensive examination is incomplete.
